Iowa FBLA Association Dues & Fees

A member is a dues paid student of Iowa FBLA and National FBLA. Dues at the local level are optional and not managed by the state association or national organization. Membership Database

The official membership database, my.FBLA allows advisers to manually register members or bulk upload membership with a pre-filled spreadsheet. When using the Program Affiliation model, Iowa FBLA Association staff will complete the registration on the chapter's behalf. Affiliation & Related Fees

Q: What dues and fees will my chapter owe to the Iowa FBLA Association?

A: Every FBLA chapter should expect to be invoiced for the following by the Iowa FBLA Association:

- **Membership Dues:** State dues are \$6.00 per member and National dues are \$6.00 per member. A chapter can also choose to pay affiliation dues instead of membership dues. See "Program Affiliation Dues Option" for more information.
- **Registrations:** Other Iowa FBLA events throughout the year have associated registration fees. These fees are charged only to chapters that register a team or members for the respective event.

Program Affiliation is an allowable expense under Perkins V in Iowa. Affiliate 100% of students in the entire program of study including both semesters of Carnegie units, MOC/work-based learning, and internship experiences.



2022-23 Program Affiliation Membership Agreement

Signatures below indicate that parties involved have an understanding of timelines, policies, and expectations associated with affiliation including

1. No affiliated fee or dues should be collected from individual students participating in the affiliation fee program. Alternative funding sources must be used to pay affiliation fees.
2. Chapter affiliation fee is based on total enrollment in a business, marketing, or information solutions program at the high school or middle school where the associated business, marketing, or information solutions program is offered. Total enrollment is determined by listing the following students in the FBLA membership spreadsheet:
 - a. All secondary school students (grades 5-12 as defined by the National FBLA bylaws) enrolled in business, marketing, or information solutions classes and/or are eligible for active FBLA membership.
3. All students in a business, marketing, or information solutions program utilizing the affiliation fee program are considered FBLA members and entered as a one-year membership expiring on July 31, 2023.
4. Participation in the affiliation program is designed to be ongoing. Chapters that sign up for affiliation must remain affiliated chapters unless they receive approval from the state association to revert to the non-affiliated chapter dues process. If an affiliated chapter chooses to leave the program, that chapter can no longer participate in the affiliate program until one of the following occurs:
 - a. A chapter submits a request for affiliation membership by the October 1 deadline.
 - b. A chapter submits a request to the Board of Directors for a waiver of rules.
